This Policy has been developed to address and give guidelines on how the University of Eldoret students shall access the necessary welfare and support services.



7. POLICY STATEMENT

The Students Welfare and Support Policy has been developed to provide guidelines on the type of welfare and support services that the students would be privileged to access to make their stay and academic experience comfortable. These services include but are not limited to; planning for orientation programmes for new students; provision of mentorship and advisory services on academics; career and other contemporary issues; provision of counseling and pastoral services; support services for international students; support services for students with disabilities and special needs; sensitization and identification of students with other psycho-social challenges and/or illnesses; support when a student is bereaved and in case of demise of a student.

1. BACKGROUND

The University of Eldoret is one of the public universities in Kenya. It is situated approximately 9km along the Eldoret-Ziwa road in Eldoret town, Uasin Gishu County. It was founded in 1946 by the white settlers as a Large Scale Farmers Training Centre. In 1984, it was converted to a teachers' training college and renamed Moi Teachers' Training College to offer Diploma Science Teachers Training. Due to the double intake crisis, the college was taken over by Moi University as a campus in September, 1990, renaming it Chepkoilel campus. Therefore the University made it a campus of natural, basic and applied science programs. In August 2010 the president, through Legal Notice No. 125 of 13th August 2010 upgraded the campus into a University College with the name Chepkoilel University College, a constituent college of Moi University. Upon the award of Charter by president on March 2013, the University College was renamed University of Eldoret.

This policy aims at guiding the student's welfare and support activities, as well, direct the operations at the dean of Students office. It will put in place an efficient and effective system that envisages the student as a client and motivate all the service providers, who are the staff in the Dean of Students Office.

3. POLICY GOAL/OBJECTIVE

To identify core welfare and support issues which influence the social and academic life of the student of University of Eldoret, and to develop policy guidelines that will assist to address these issues.

4 POLICY

4.1 Planning for orientation programs for new students

The office of the Dean of Students will be required to plan and facilitate orientation of new Students. The students will be enlightened on the University structure, Principles and Core Values. They will also be sensitized on the Rules and regulations that will govern their stay at the university.

4.2 Provision of mentorship and advisory services on academics, career and other contemporary issues

From time to time, the office of the Dean of Students will organize mentorship programs targeting various groups of students to build on their capacities and skills. It will also provide advisory services seeking guidance on issues related to their academic progression e.g. deferment of studies, leave of absence, special examinations and future careers.

4.3 Provision of counseling and pastoral services

The student counseling and pastoral unit will be open for students seeking these services as per the students counseling policy of the University of Eldoret.

4.4 Support services for international students

In order to curtail challenges faced by International Students while in the process of integration into the University community, the University of Eldoret is committed to providing relevant guidance and non-financial support to make their stay comfortable through the Office of the Dean of Students.

4.5 Support services for students living with disabilities and special needs

Support to students living with disabilities and/ or those who have special needs will be facilitated and guided by the relevant university policies on accommodation, policy on PWD mainstreaming and any other policy that may be put in place from time to time.

4.6 Sensitization and identification of students with other psycho-social challenges and/or illness

For students with varied non-communicable illnesses such as psycho-social indisposition, injury or disease, the Office of the Dean of students shall sensitize and identify students that require intervention/referral.

4.7 Student Bereavement

In the event that a student experiences the death of an immediate family member or a relative as defined in this policy document, the student will present themselves to the counsellor in order to be assisted in handling the situation by a counsellor. Thereafter he or she will be facilitated to take a leave of absence of not more than ten (10) days.

4.8 Demise of student

In case of death of a student this policy establishes uniform guidelines for providing assistance to the immediate family to the deceased student which is limited to hearse hiring, purchase of coffin and mortuary expenses.

4.1.1 Eligibility

All bona fide students of University of Eldoret are eligible for benefits under this policy.

4.1.2 Funeral facilitation

In case of such occurrence, Office of the Dean of Students will notify the family of the deceased student and prepare a death announcement to all designated areas and relevant concerned offices in the University. Office of the Dean of Students shall;

- (a) Prepare and post the death announcement.
- (b) Prepare a request for approval to the Vice-Chancellor, through the Deputy Vice-Chancellor (Academics and Students Affairs) for the funeral expenses (hearse, coffin and mortuary) and appropriate travelling allowances of the officers representing the University.
- (c) Prepare a condolence message for the Vice-Chancellor's signature.
- (d) Assign person to attend, limited to 9 people that include; Two (2) staff members from Dean of Students, two (2) members of Students Council, Class Representative, roommate and any other three (3) students, provided such absence from duty will not interfere with normal operations of the University.
- (e) Liaise with Transport Officer to avail a vehicle.
- (f) Funds to be drawn from student welfare and other activities vote.

5. IMPLEMENTATION

- (a) This policy shall be implemented in accordance with relevant legislation, alongside other policies of the University.
- (b) Operationalization of this policy will be achieved through funding from Students' Welfare and Other Activities Vote.

6. EFFECTIVE DATE

This Policy shall be effective from the date it is approved by the University Council.

7. REVIEW

This Policy shall be reviewed from time to time as need arises.
